US\$ 0,55 per video as screening fee), foodstuff (5%).</p> <p><b>Duty free on to CDs, DVDs, LDs, VCDs unless large quantities are imported.</b></p>	<p>Consignee's presence required for Customs clearance on all sea &amp; overland shipments.</p> <p>All used HHGs are allowed free of duty but subject to owner having a valid two year Residence Permit. In the absence of a two year Residence Permit, shipment can be cleared upon payment of Customs Deposit, value of which will be advised by the Customs.</p>

Commodity shipments	<ul style="list-style-type: none"> <li>Commercial invoice which must indicate currency, C &amp; F value.</li> <li>Amount of packages, weight/measurement manufacturer's name, country of origin.</li> <li>Packing List.</li> <li>Insurance Certificate (if insured)</li> <li>Certificate of Origin (legalised).</li> </ul>	<p>Subject to 10% customs duty.</p>	<p>All shipments are subject to the Customs' inspection.</p>
Motor vehicles	<ul style="list-style-type: none"> <li>Commercial invoice on new vehicles.</li> <li>Original Bill of Lading</li> <li>Original Insurance Policy.</li> <li>Certificate of ownership or Export certificate from country of origin.</li> </ul>	<p>Customs duty payable at 15% of the value assessed by the customs (CIF).</p>	<p>Importation allowed for left hand drive vehicles only.</p> <p>Prior import approval is required for all right hand drive vehicles.</p> <p>Consignee must be present for customs inspection.</p>
Pets	<ul style="list-style-type: none"> <li>Copy of the Airway-bill.</li> </ul>	<p>Import licence to be obtained prior to booking</p>	<p>Quarantine is normally for a month.</p>
